Judicial Opinions as Literature - ADM Jabalpur v

On 24 August 2017, a nine judge bench of the Supreme Court of India handed down its decision in the important constitutional case of Puttaswamy v Union of India [pdf]. In a remarkable and wide ranging 547 page judgment the Court ruled unanimously that privacy is a constitutionally protected right in India.

Case Law, India: Puttaswamy v Union of India, Supreme

Appointed out of turn, the new chief justice turned out to be a committed judge and a few months before his retirement in 1977 gifted to the nation the infamy of ADM Jabalpur. Four of the five judges on the bench deciding this case – Ray, Beg, Chandrachud and Bhagwati – had gone in government’s favour; poor Khanna was the lone dissenter.
